NEW WATER AND WASTEWATER RATES

The County of Brant strives to maintain cost effective and efficient municipal water and wastewater systems. These systems are funded on a user-pay basis. As adjustments to the rates may be required from time-to-time to reflect the cost of operating and maintaining the systems, under ever increasingly stringent Provincial regulations, the County reviews these costs annually.

The results of the review at the end of 2008 identified that some adjustments to the rates were required. Specific adjustments to the monthly water and wastewater rates adopted by Brant County Council are as follows:

- 1) The monthly residential wastewater base rate is adjusted from \$13.00 to \$13.75 with the usage fee adjusted from \$0.80 to \$0.85 for each cubic meter of water used.
- 2) The industrial, commercial and institutional wastewater rate remains at 93.5% of the water charge.
- 3) The monthly residential base water rate is adjusted from \$44.40 to \$46.62. This includes up to 5 cubic meters water usage each month.
- 4) The incremental residential water rate is adjusted from \$0.56 to \$0.59 for each cubic meter of water used after 5 cubic meters of water usage each month.
- 5) Industrial, commercial and institutional municipal water users will see an increase of approximately 5%. (Specific rates are shown on reverse side of this notice.)
- 6) The bulk fill water rate is adjusted from \$1.78 to \$1.87 per cubic meter.
- 7) The new rates are effective April 1, 2009.
